

Sastanak u Ministarstvu ekonomskog razvoja

19.01.2021.

Zdenko Janković, Rajko Radusinović i Đina Janković, predstavnici Udruženja zaštite na radu Crne Gore, su 19. januara 2021. imali sastanak u Ministarstvu ekonomskog razvoja, sa g-dinom ministrom Jakovom Milatovićem. Ministra su tom prilikom upoznali sa aktivnostima koje je udruženje realizovalo prethodnih godina, sa značajem i ulogom koju je ova strukovna organizacija ima, kao i sa programskim ciljevima udruženja vezanim za implementaciju zaštite i zdravlja na radu u Crnoj Gori.

Predlog programskih ciljeva, koje su predstavili, a sa kojim je ministar bio saglasan, sastoji se od:

1. Uvođenja nulte tolerancija u oblast zaštite i zdravlja na radu
2. Podizanje nivoa kvaliteta rada i kulture zaštite i zdravlja na radu
3. Uvođenje sistema kvaliteta u privredna društva
4. Uvođenje zaštite i zdravlja na radu u obrazovni sistem Crne Gore
5. Podizanje nivoa kvaliteta usluga ovlašćenih organizacija za zaštitu i zdravlje na radu
6. Formiranje Nacionalnog savjeta za ZZNR

Kada je u pitanju formiranje Nacionalnog savjeta za oblast ZZNR, koji postoji u svim zemljama okruženja osim u Crnoj Gori, ministar je mišljenja da bi se pitanja iz oblasti zaštite i zdravlja na radu, mogla, u ovom trenutku, delegirati i Socijalno ekonomskom savjetu.

Postignuta je saglasnost da je neophodno da Ministarstvo ekonomskog razvoja i Udruženje zaštite na radu Crne Gore, zajedno sa socijalnim partnerima, učestvuju u daljem unaprjeđenju zaštite i zdravlja na radu i stvaranju povoljnijih uslova rada za zaposlene u Crnoj Gori, a sve u cilju smanjenja broja povreda i profesionalnih oboljenja.





Report – Meeting at the Ministry of Economic Development

January 19th 2021

Zdenko Jankovic, Rajko Radusinovic and Djina Jankovic, representatives of the Safety at Work Association of Montenegro, had a meeting at the Ministry of Economic Development, with Mr. Minister Jakov Milatovic on January 19th 2021. On that occasion, the Minister was acquainted with the activities which SWAM has implemented in the previous years, with the importance and role that this professional organization has, as well as with the program goals of the Association related to the implementation of occupational safety and health in Montenegro.

The proposal of program goals, which they presented, and which the Minister agreed with, consists of:

1. Introduction of zero tolerances in the field of safety and health at work
2. Raising the levels of quality of work and the culture of safety and health at work
3. Introduction of quality systems in companies
4. Introduction of safety and health at work in the educational system of Montenegro
5. Raising the level of quality of services of authorized organizations for safety and health at work
6. Establishment of the National Council for OSH

When it comes to the formation of the National Council for OSH, which exists in all neighboring countries except Montenegro, the Minister believes that issues in the field of occupational safety and safety could at this time be delegated to the Social and Economic Council.

It was agreed that it is necessary for the Ministry of Economic Development and the Safety at Work Association of Montenegro, together with the social partners, to participate in the further improving of occupational safety and health and creating more favorable working conditions for employees in Montenegro, all in order to reduce the number of injuries and occupational diseases.
